GENERAL GUIDELINES

- **Entry** is available to all local area artists. Entrants may submit up to 1 large artwork (up to 40"x50") or 2 small (under 20"x24") for an exhibit. A non-refundable application fee of \$10 is due from anyone submitting art. This application and release form must be completed and submitted in order to have works displayed. Artwork previously exhibited at the Price Center Gallery is not eligible. Subject matter should be appropriate for all visitors to the Price Center, which is a multi-generational, family oriented venue located at 222 W. San Antonio St. in downtown San Marcos. *See specific Call for Entry Exhibition guidelines if applicable.
- **Only ORIGINAL** works of art, including fine art prints, sculptural pieces, textile creations, decorated porcelain and other pottery works, photographs and digital art signed by the artist will be accepted in shows. We encourage artists to enter recent work, and all entries must have been done entirely by the artist. Reproductions (e.g., Giclées) from paintings and drawings are NOT allowed.
- **Artwork displayed is up to the discretion of the Arts Committee and the Price Center.**
- All artwork must be dry. Two-dimensional art should be framed, or unframed with finished edges (no visible staples). Artwork must be ready for hanging on our hanging system with tightly stretched wire securely attached on both sides, down 1/4 of the artwork height measured from the top of the piece. No saw tooth hangers. Sculptural and other 3-dimensional works will be considered based on size and display availability.
- **Sales:** We encourage you to have your artwork for sale. Prices may not be changed after entry. Artwork sold will remain in the gallery for the duration of the show. The Price Center requires a 20% commission on sales.

Media Guidelines

Examples of original art:

Digital art – Specify pigment inkjet print, C-print, etc.

Digital photo art – Specify pigment inkjet print, C-print, etc.

Drawing – Specify graphite, charcoal, Conté, etc.

Fiber art – Specify weaving, quilt, needlework, etc.

Mixed Media (including collage) – Specify mediums.

Painting – Specify oil, acrylic, watercolor, pastel, gouache, encaustic, etc.

Photography – Specify silver gelatin print, pigment inkjet print, C-print, etc.

Printmaking – Specify etching, lithograph, woodcut, silkscreen, etc.

Assemblage – Specify found object, porcelain, etc.

Jewelry – Specify beads, gold, silver, ceramic, copper wire, etc.

Pottery – Specify earthenware, porcelain, stoneware, etc.

Sculpture – Specify bronze, clay, glass, wood, fiber art, etc.

ARTIST'S AGREEMENT

1. This is a mutual agreement between the Greater San Marcos Area Seniors Association (GSMASA) / Price Center and the artist. **The Center agrees to exhibit only artwork selected by the juror(s).** In the event the artwork sells, it will remain on display for the duration of the show, and the artist will provide a 20% commission of the sale price to the Price Center. The artist is responsible for collecting, reporting, and paying the sales taxes to the State of Texas.
2. In order to maintain the integrity of a juried show, only juried artwork will be shown. **Selected artwork must remain in the Price Center for the duration of the exhibit, and must not be removed by the artist for any reason, including if it is sold.** At the end of the show, the artist is responsible for picking up his/her own artwork on the date and time specified on the entry form. If the art is to be picked up by someone other than the artist, prior arrangements must be made with the Price Center and proper identification will be required at the time of pickup.
3. All artists who are engaged with other galleries are responsible for securing his/her release from that gallery.
4. All supplemental materials (such as books, marketing materials, prints, etc.) may be on display/for sale on the exhibition's opening night and corresponding activities. All other stipulations will be individually based on agreement with the Price Center Director and/or Arts Committee. Proposals for sales must be submitted in writing.

WAIVER OF LIABILITY ACKNOWLEDGED

1. The Artist understands and agrees they have read the conditions and agrees to abide by said conditions while releasing the Price center and its operators from liability for loss or damage to works lent. The Artist shall assume any responsibility or obligation for any loss or damaged item(s). It is further understood that items on display are not and will not be covered under any insurance policy owned by the — and it is the artist's burden of cost. This waiver will be kept on file for up to one year following the exhibit.
2. The undersigned acknowledges and agrees that neither GREATER SAN MARCOS AREA SENIORS ASSOCIATION (GSMASA), the PRICE CENTER AND THEIR DIRECTORS, officers, AGENTS, EMPLOYEES, VOLUNTEERS, and the City of San Marcos ("CITY"), or agents will provide any security or protection for entries and that their display will be at their sole risk.
3. The Price Center is an event center where artwork is to the public and closed for private events where employees of the Price Center will not be present. The Price Center (and employees) reserve the right to temporarily remove artwork based on necessity for daily operations and event rentals.
4. The undersigned does for himself, herself, his and her heirs and assigns, hereby waive, release and discharge the GREATER SAN MARCOS AREA SENIORS ASSOCIATION (GSMASA), the PRICE CENTER AND THEIR DIRECTORS, officers, AGENTS, EMPLOYEES, VOLUNTEERS, and the City of San Marcos ("CITY"), their members or agents, from any and all manner of actions, suits, damages, claims and demands whatsoever, in law and equity for any loss or damage to the undersigned's property, and for any personal liability.
5. The undersigned grants permission to the GSMASA/Price Center or its agents to photograph his or her entries for use in show publicity and promotion.
6. In the event that a purchaser contacts the artist directly, the artist must contact Price Center staff with all appropriate information at 512-392-2900 or info@price-center.org Commission checks for purchased artwork must be made out to: Price Center. **The artist is responsible for delivering purchased artwork to the buyer when the gallery show is taken down.**
7. **FINALLY, the undersigned acknowledges that he or she has read and agrees to adhere to all of the agreements, guidelines and understandings in this Show Entry Letter.**
